Which AMS components qualify for the PowerGard Protection Plan?

All new John Deere AMS StarFire receivers, GreenStar/GS2 displays, and mobile processors are eligible.

PowerGard Eligible AMS Components

StarFire™ iTC Receivers, Original GS Displays, Mobile Processors, GS2 2100 Displays, GS2 2600/2630 Displays, 1800 Displays.

Purchase Intervals: You can purchase a PowerGard plan anytime up to 95 days from the date of delivery of the new component and start of the John Deere basic warranty, for the lowest possible price. The PowerGard Protection Plan is not available for purchase after the 95 days.

What does the PowerGard Protection Plan cover?¹

Coverage for new AMS components: All main parts and sub-components of new John Deere AMS main components are covered for mechanical breakdown caused by a defect due to faulty materials or original workmanship.

Coverage limits: Each individual PowerGard contract on each covered component will pay up to one full replacement cost during the coverage period. This does not include any replacements or repairs covered within the 12-month basic warranty period. The dollar limit, or “maximum cumulative recovery,” on any AMS component is the full list price of any replacement unit, excluding software costs.

Dealership labour: PowerGard pays for dealership labour to install your replacement component, limited to about an hour of service labour. (Installation is typically less than one full hour of labour.) PowerGard does not cover special labour costs such as overtime, diagnostic labour, etc.

Is there a deductible fee?

No! There is \$0 deductible when an AMS component is replaced or repaired under the PowerGard coverage term.



What coverage terms are available for new AMS components?

All PowerGard Protection Plans for new, in-warranty units include the underlying basic warranty terms,² and can be extended to the following maximum coverage terms:
